This scholarship was established by Dr. Jack H. Lockwood and his wife Donna J. Bradford Lockwood, former Three Rivers area business people. Jack received his law degree from the University of Notre Dame. He then went on to own and operate Lockwood Tax Center of Kalamazoo, MI. Jack was a hard worker whom devoted much of his time to his business and his customers. When he wasn't working he enjoyed racing standard bred horses, rescuing retired grey hound dogs, and traveling. The scholarship is to honor the memory of their son Dennis, and their nephew Gary, along with their friends.

PURPOSE

To provide financial assistance for higher education learning based on merit plus need.

ELIGIBILITY

Applicants for this scholarship must satisfy the following criteria:

1. Graduation from Three Rivers High School.
2. Have attained a minimum grade point average of 2.5 in high school.
3. Desire to attend a Michigan Institution of higher education, or an accredited trade school of business, accounting, nursing, or industrial arts.
4. Be available for a personal interview with the scholarship selection committee.

AMOUNT OF SCHOLARSHIP

The scholarship shall be in the amount of \$1,000.
